**JUDGMENT SUMMARY**

As evidenced within the Judgment and Order Respondents have violated all Thirty (30) Articles of the Universal Declaration of Human Rights thereby violating all Thirty (30) Articles of Public Laws-101 upon a Private Membership Association established outside the United States corporation or its political subdivisions. Arbitrary life threatening statements directed at Claimant as a "sovereign citizen" and forcing Claimant's association within a private member Bar association, more specifically Washington State Bar Association, within the political subdivision state of Washington or Washington state resulted in the Default judgment. The original (1878)

Constitution of the political subdivision, already placed within the corporate municipality of Washington D.C. city state with the approval of the District of Columbia Act of 1871 [District Of Columbia Organic Act Of 1871.pdf \(PDFy mirror\) \(archive.org\)](#), only specified a Judicial branch, not a Judiciary, and did not require members of a bar evidenced in Article VIII, Judicial of said Constitution [Constitution : \[adopted in convention July 27th, 1878\] : Washington \(State\) : Free Download, Borrow, and Streaming : Internet Archive](#) (page 6), never officially adopted.

The Judicial branch of the political subdivision was arbitrarily replaced with a Judiciary within the 1879 Constitution and occultists for the Washington State Bar Association now control all bar proceedings thereby forcing association upon the inhabitants therein vacant a written, signed, and published social compact by and between the populace to authorize the judicial body politic, a violation of the codified *Law of Nations*. Claimant is an international person in social compact with the permanent population of The United States of America and has natural obligations, rights, and duties that Respondents arbitrarily refused to acknowledge, whether by lack of knowledge or by deception, the latter suspected as Claimant attempted multiple times to clarify Claimant's nationality.

## **IN THE MATTER OF ANDREY RUNOV**

As a Russian National currently granted the privilege of residency and work within the foreign political subdivision state of Washington or Washington state found in Default with an International Tribunal, it is hereby requested that Respondent Andrey Runov, hereinafter "Andrey", or the registered agent acting on behalf of, contact the Political and Judicial Special Representative William Emory Reffett, hereinafter "Special Representative", to initiate a meeting with Claimant and Special Representative for the purpose of scheduling interaction times between Claimant and Claimant's children. No Bar member affiliated with the masonic Inns of Court and its Temples shall be acknowledged at any meetings with Andrey nor will any policies utilized by the Judiciary of the foreign political subdivision be applicable. All Bar members on behalf of Andrey are welcome to dissolve all association with Andrey and cease any further actions in the matter of Andrey and Claimant.

with Andrey's alleged marriage to Claimant, thereby nullifying the alleged marriage to Claimant, overlooked or disregarded by the Bar members for Washington State Bar Association.
